

A. ALL SERVICES MUST BE PERFORMED TO QUALIFY FOR THIS PROTECTION PLUS WITHIN THE SPECIFIED MILEAGE INTERVALS AND TAKES EFFECT AFTER THE MANUFACTURER WARRANTY AND ANY OTHER WARRANTY EXPIRES. THIS PROTECTION PLUS IS NOT AN EXTENSION OF THE MANUFACTURER WARRANTY. IT IS SUBJECT TO THE TERMS AND CONDITIONS STATED BELOW.

**Towing Assist™** — included as a complimentary service with the SelTec® Premium Oil Change (EVERY 5,000 Miles) Coverage extends for 5,000 miles or 150 days which ever comes first. Customer will be eligible for reimbursement on the tow bill when towed back to the participating dealership for repair. Credit on their repair bill (up to \$100) will be applied with Service Manager approval. Customer will use towing coverage by the manufacturer first and after warranty use the tow company the dealership specifies. Under no circumstances will the credit exceed the tow bill up to the maximum amount of \$100.00 (One Hundred dollars).

Engine (gasoline) that have been serviced by the use of SelTec® Premium Oil Change Service (EVERY 5,000 Miles) which includes SelTec® #101 Premium Oil Additive.  
Fuel System that have been serviced by the use of \* SelTec® Complete Fuel Injection Service (EVERY 15 K/12 months) which includes, SelTec® #3636 Air Intake Cleaner, SelTec® #303 Combustion Chamber Cleaner & SelTec® #1212 Fuel Cleaner  
Automatic Transmission that have been serviced by the \* SelTec® Premium Transmission Service (EVERY 30 K/24 months) which includes, SelTec® #202 Transmission Flush & SelTec® #606 Transmission Conditioner.  
Front Differential that have been serviced with \* SelTec® Front Differential Service (EVERY 30 K/24 months) which includes, SelTec® #404 Gear Additive or SelTec® Synthetic Gear Oil #7590 or #75140.  
Rear Differential that have been serviced with \* SelTec® Rear Differential Service (EVERY 30 K/24 months) which includes, SelTec® #404 Gear Additive or SelTec® Synthetic Gear Oil #7590 or #75140.  
Transfer Case that have been serviced with \* SelTec® Premium Transfer Case Service (EVERY 30 K/24 months) which includes, SelTec® #606 Transmission Conditioner.  
Brake System that have been serviced with \* SelTec® Premium Brake Fluid (EVERY 30 K/24 months) which includes, SelTec® #808 Brake Fluid & SelTec® #95 Brake Service Kit which includes SelTec® #8484, #8585, Brake Treatment products.  
Power Steering System that have been serviced with \* SelTec® Premium Power Steering Service (EVERY 30 K/24 months) which includes, SelTec® #4040 Power Steering Flush & SelTec® Power Steering Fluid with Conditioner #4242.  
Cooling System that have been serviced with \* SelTec® Premium Cooling System Service (EVERY 30 K/24 months) which includes, SelTec® #707 Cooling System Flush & SelTec® #1010 Cooling System Conditioner.

B. Terms, Duration and Extension of This Protection Plus  
This Protection Plus is subject to the terms and conditions contained herein:

**Schedule A** The initial service(s) must have been performed within specified mileage as interval shown in section F, as shown on the odometer, unless the manufacturer recommends a shorter service interval. This Protection Plus for Automatic Transmissions, Power Steering, Brake System, Front Differentials, Rear Differentials, Transfer Cases and/or Cooling System will be continued by the performance of the proper SelTec® Service within 30,000 miles and 24 months of the previous service. This Protection Plus for Engines (gasoline) will be continued by the performance of the SelTec® Premium Oil Change within 3,000 miles and 120 days of the previous service and SelTec® Complete Fuel Injection Service every 15,000 or 12 months which ever comes first. From the date of your Protection Plus enrollment, **the vehicle's engine must be serviced only with the proper grade and weight of the engine oil, recommended by the vehicle manufacturer. Timing belt and air and oil filter must be replaced and emission control system maintained in accordance with the vehicle manufacturer's recommendations. All services referred to in Section A must be performed by a licensed professional service center.**

**Schedule B** The initial service(s) must have been performed between the specified mileage interval as shown in section F, as shown on the odometer, unless the manufacturer recommends a shorter service interval. This Protection Plus for Automatic Transmissions, Power Steering, Brake System, Front Differentials, Rear Differentials, Transfer Cases and/or Cooling System will be continued by the performance of the proper SelTec® Service within 30,000 miles and 24 months of the previous service, unless the manufacturer recommends a shorter service interval. This Protection Plus for Engines (gasoline) will be continued by the performance of the SelTec® Premium Oil Change within 3,000 miles and 120 days of the previous service and SelTec® Complete Fuel Injection Service within 15,000 miles and 12 months of the previous service. **From the date of your Protection Plus enrollment, the vehicle's engine must be serviced only with the proper grade and weight of the engine oil, recommended by the vehicle manufacturer. Timing belt and air and oil filter must be replaced and emission control system maintained in accordance with the vehicle manufacturer's recommendations. All services referred to in Section A must be performed by a licensed professional service center.**

Protection is not to exceed ten (10) years from model date of the vehicle, or 200,000 miles, whichever comes first. This Protection Plus will take effect 1,000 miles AND 90 days after the SelTec® service(s) has been performed by a professional technician. You may not change your own oil. In the event of a claim, you must provide SelTec® Corporation with satisfactory evidence, according to Section E, that all of the required services referred to in Section A were performed. A professional technician must perform an approved SelTec® maintenance procedure using proper SelTec® products and equipment. A grace period of 500 miles or 30 days will be extended in order to stay within service interval compliance, including initial service.

C. Covered Components

Payment of claims under this Protection Plus is limited to the *labor time* necessary to make repairs or to replace any irreparably damaged parts as allocated by the *Motor or Mitchell Flat Rate Guide* or other industry accepted flat rate guide, **multiplied by the commercial repair shop's posted hourly rate not to exceed \$90 per hour, plus the reasonable cost of replaced parts of like kind and quality at the administrator's discretion.** This SelTec® Protection Plus covers only the lubricated parts contained within:

Gasoline Engine Parts: (Diesel Engines are not covered) Pistons and Rings, Cam Shafts and Bearings, Timing Gears or Sprockets, Turbo Bearings Rods and Rod Bearings, Valve Lifters, Intake Valves and Guides, Oil Pump, Cylinder Liners or Bores, Wrist Pins and Bushings, Rocker Arms and Pivots, Push Rods, Distributor Drive Gear, Crankshaft and Bearings, Oxygen Sensors.

EXCLUSIONS: Timing Belts (chains) and damage to engine due to broken timing belts (chains) excluded. Grinding adjustments excluded.

Fuel System: Covers the fuel injectors. Limited to malfunctions due to deposits.

Automatic Transmission: Covers only the internally lubricated parts. Leaking transmission seals, gaskets, transmission housing or case are not covered. Electrical components, such as solenoids are also not covered. **Proper fluids meeting vehicle manufacturer's specifications must be used. Manual Transmission are not covered.**

Drive Line Front Differentials: Covers only the lubricated parts contained within the front differential housing or case. The front differential housing or case, pre-packed axle bearing(s), U-joints, CV joint(s) and boot (s) are not covered by this Protection Plus.

Drive Line Rear Differentials: Covers only the lubricated parts contained within the rear differential housing or case. The rear differential housing or case, axle(s), pre-packed axle bearing(s), U-joint(s) and CV joint (s) are not covered by this Protection Plus.

Drive Line Transfer Cases: Covers only the lubricated parts contained within the transfer case. The housing or case, U-joint(s), CV joint(s) and driveshaft(s) are not covered.

Drive Line Manual Transmission / Transaxles: Are Not Covered.

Power Steering: Covers only the power steering steering pump. Gear box or rack, hoses, belts, brackets, seals and gaskets are excluded.

Brake System: Covers only the pump, valves, master cylinder, calipers, and metalized hoses. Pads, rotors, shoes, ABS sensors, controller or other electrical parts are not covered by this Protection Plus.

Cooling System: Covers only the heater core, water pump, freeze plugs and radiator. Hoses, clamps, thermostats and engine components are not covered by this Protection Plus.

D. Conditions and Exclusions of This Protection Plus

If the vehicle odometer has been changed or altered, or if odometer has ceased to function, coverage under the terms of this Protection Plus are not in effect. This Protection Plus covers only legally registered passenger cars, vans, SUVs and pick-up trucks with a GVW of 6,500 pounds or less. Motorcycles, RV's and vehicles with more than two axles are excluded. Vehicles used for competitive purposes are excluded.

This service excludes in-house maintenance / repair facilities. In the case of a leased vehicle, the lessee must be primarily obligated for repairs and maintenance. If vehicle is used for towing a trailer or other vehicle or object, this Protection Plus is not in effect and does not cover this vehicle. Any claim resulting from collision, fire, theft, vandalism, contamination of fluids, fluid leaks of any kind, acts of God, misuse, abuse, negligence, lack of normal maintenance required by the vehicle manufacturer renders this Protection Plus null and void. Pre-existing conditions, damage to system components prior to the service are excluded and may be verified through independent parts analysis at the discretion of SelTec® Corporation. To keep this Protection Plus in effect you must keep all receipts and repair orders for maintenance and services required by this Protection Plus. Failure to furnish all necessary records will render this Protection Plus null and void. One payable claim per service interval is permitted. The decision of SelTec® Corporation is final in all cases and will be rendered within 30 days of submission.

E. Claims and Repair Procedures

In the event of a claim, you must notify SelTec® Corporation Claims Administrator, *prior to having any repairs made* by Fax 1-877-234-6210.

You must provide the designated claims administrator with information from all of the following:

1. All service repair orders, including all applicable SelTec® Part Numbers stated in Section "A" showing compliance with the terms and conditions of this Protection Plus for each component covered, e.g., Automatic Transmission, Front Differential, Rear Differential, Transfer Case, Power Steering, Brake System, Cooling System, Fuel System and Engine.
2. If necessary, all service repair orders showing compliance with the terms and conditions of previous protection plans or service warranties, (including OEM and any extended warranties) and proof of previous plan.
3. Purchase agreement or Lease agreement if vehicle is leased with original dates.
4. A complete statement of damage and estimated repair costs.
5. This page must accompany all claims.

If required, you must ship the damaged parts, as well as a representative pint sample of vehicle fluid involved with the damaged parts at vehicle owners expense, to:

Front Differentials shall not exceed \$5,000 (five thousand)(1-36K initial service)  
Rear Differentials shall not exceed \$5,000 (five thousand)(1-36K initial service)  
Transfer Cases shall not exceed \$5,000 (five thousand)(1-36K initial service)  
Manual Transmissions are not covered  
Power Steering shall not exceed \$5,000 (five thousand)(1-36K initial service)  
Brake System shall not exceed \$5,000 (five thousand)(1-36K initial service)  
Cooling Systems shall not exceed \$5,000 (five thousand)(1-36K initial service)

Coverage B Initial Service as specified below:

Engine shall not exceed \$2,500 (two thousand five hundred)(10-25K initial service)  
Automatic Transmissions shall not exceed \$1,250 (one thousand two hundred fifty)(36-80K initial service)  
Front Differentials shall not exceed \$2,500 (two thousand five hundred)(36-80K initial service)  
Rear Differentials shall not exceed \$2,500 (two thousand five hundred)(36-80K initial service)  
Transfer Cases shall not exceed \$2,500 (two thousand five hundred)(36-80K initial service)  
Manual Transmissions are not covered
